

**Terms, Conditions, and Rules (the “Official Rules”) for the Barrett Rifle System  
Giveaway Sweepstakes (the “Sweepstakes”)**

All entrants must read these Official Rules before entering the Sweepstakes.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING.

This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook, Instagram, or Twitter.

This Sweepstakes is governed by the laws of the State of Tennessee, and all claims must be resolved in the federal or state courts located in Tennessee.

**1. Eligibility.** Eligibility is limited to only legal residents of the 49 United States and the District of Columbia (Rhode Island excluded) who have reached the age of majority (as defined by the law of the state in which entrant resides) as of December 27, 2018.
